

## Information about processing of personal data processing

The Italian legislative decree n.196 of 30 June 2003 (Personal Data Protection Code) states that everyone has the right to protect his/her personal data concerning it states that such data be processed by respecting data subjects' rights, fundamental freedoms and dignity, particularity with regard to confidentiality, personal identity and the right to personal data protection.

Therefore pursuant section. 13 of the Personal Data Protection Code we provide you the following information:

- a) the personal data communicated, even in an oral way, by the data subject, to the company hereinabove, during commercial contacts, precontractual negotiations or in the way of fulfilling contractual obligations, shall be subjected to processing, by collection, recording, organization, storage, adaption, alteration, retrieval, consultation, use, alignment, combination, blocking and every other convenient operation, even through the aid of electronical means on the purpose to:
  - b) i) performe by the Company the legal duties concerning accounting and fiscal matters and every other legal obligation,
  - c) ii) obtain precontractual information
  - d) iii) perform the agreement executed with the Company
  - e) iv) exclusively with respect to the data regarding the performance of economical activities, to the purpose of providing business information or advertising or direct marketing, or for marketing research or interactive business communications
  - f) v) carry out administrative (administration of production and logistics), statistical (study and planning), accounting, financial, insurance and credit protection purposes;
  - g) vi) to developpe commercial and industrial relations
- h) the replies to the questions are voluntary
  - i) the eventual refusal by the data subject can prejudice the performance of the negotiations in connection to which they are required or hinder the Company in performing its obligations:
  - j) these data can be disclosed to other companies belonging to the Fiat Group, Fiat Industrial and/or other subjects, operating, on behalf of Iveco S.p.A. under specifical contractual relationships, in member states of the EU or to subjects belonging to the Iveco's distributorship network, to be processed, exclusively for the purposes hereabove contemplated by letter a). In addition, the data regarding denomination, address and/or telefax numbers and kind of activity, shall be disseminated, only for commercial promotion purposes.
  - k) the processing could be manage with or without the help of electronic or automated means;
  - l) controller of the data processing : Iveco S.p.A.processor: the updated list of the pro-tempore processors of the processings mentioned in letter a) hereinabove is available c/o Iveco S.p.A. - Legal Affairs, Via Puglia 35, 10156 Torino.

In every time you will be able to exercise your rights against the data controller in compliance with the section 7 of the Italian legislative degree that reproduce integrally:

### Section 7 (Right to Access Personal Data and Other Rights.)

1. A data subject shall have the right to obtain confirmation as to whether or not persona! data concerning him exist, regardless of their being already recorded, and communication of such data in intelligible form.
2. A data subject shall have the right to be informed
  - a) of the source of the persona! data;
  - b) of the purposes and methods of the processing;
  - c) of the logic applied to the processing, if the latter is carried out with the help of electronic means;
  - d) of the identification data concerning data controller, data processors and the representative designated as per Section 5(2);
  - e) of the entities or categories of entity to whom or which the persona! data may be communicated and who or which may get to know said data in their capacity as designated representative(s) in the State's territory, data processor(s) or person(s) in charge of the processing.
3. A data subject sha!1 have the right to obtain
  - a) updating, rectification or, where interested therein, integration of the data;
  - b) erasure, anonymization or blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected or subsequently processed;
  - c) certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.
4. A data subject shall have the right to object, in whole or in part,
  - a) on legitimate grounds, to the processing of personal data concerning him/her, even though they are relevant to the purpose of the collection;
  - b) to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else for the performance of market or commercial communication surveys.
